OLD BUSINESS

Bill 4191 - AN ORDINANCE GRANTING A SPECIAL USE EXCEPTION TO MAKO KELLMAN ON BEHALF OF ANVIL REAL ESTATE & DEVELOPMENT, LLC, FOR OPERATION OF A RESTAURANT WITH A DRIVE-THROUGH.

This ordinance is for approval of a Dutch Brothers Coffee at 15200 Manchester Road.

LEGISLATION

Bill 4194 - AN ORDINANCE GRANTING A SPECIAL USE EXCEPTION TO JASON KESLER FOR JERSEY MIKE'S SUBS, FOR OPERATION OF A RESTAURANT WITH FRONT YARD PARKING.

This ordinance is for a new Jersey Mike's Subs at 15005 Manchester Road. The petition has been approved by the Planning & Zoning Commission.

Bill 4195 - AN ORDINANCE CORRECTING ADOPTION OF THE 2015 EDITION OF THE INTERNATIONAL MECHANICAL CODE AND AMENDING SECTION 7-43 OF THE CODE OF ORDINANCES OF THE CITY OF BALLWIN.

This ordinance is to correct a typographical error in Section 1, referring to plumbing systems rather than mechanical systems.

Bill 4196 - AN ORDINANCE AMENDING THE PURCHASING POLICIES FOR THE CITY OF BALLWIN.

This ordinance is to change the purchasing policies for the City of Ballwin. It will lower the threshold for emergency repairs/purchases that need to be recorded in the Board Meeting minutes to \$10,000 from \$15,000. It will also allow purchases of \$10,000 or less to be approved by the department head and the City Administrator without having to be recorded in the minutes of the next regular meeting of the Board of Aldermen.
