Filed Articles of Incorporation in November 2010.

WCDC to be housed in the Town and Country Police Department.

West Central Dispatch Center History

Existing agency 9-1-1 Police Dispatchers would apply with WCDC.

Participation Agreement and By Laws created.

WCDC founded under rules set forth by Chapters 70 and 321 of the Revised Statutes of Missouri.

In 2021 Ladue joined WCDC as the fourth member agency.



A minimum of Four (4) Full-Time Positions and Two (2) Part-Time Positions would be added to existing WCDC Staffing Levels. Accomplished via an application process, as all current WCDC Dispatchers have done.

Initial staffing goals are to have a former Ballwin Dispatcher added to each crew and assigned to the Ballwin channel as other Dispatchers are acclimated to Ballwin and vice versa.


Current Ballwin Proposed Budget for 2025 is \$1,159,000.




